Consolidated Pretrial Order and Motions in Limine filed by: August 16, 2019

Mandatory Pretrial Conference: August 26, 2019 at 2:30 p.m.

Available Trial Dates: September 16th through September 20th and September 23rd through September 27th

Parties are hereby notified to set all other business aside and to appear in the courtroom of Judge Dax E. López, located in Courtroom 3D at the DeKalb County Courthouse, 556 N. McDonough Street, Decatur, Georgia 30030.

This is a TWO-WEEK Trial Calendar. All cases should expect to be reached during the week of trial. Cases may be called out of order as scheduling demands. Parties will be specially set for trial during the pre-trial conference. The parties are reminded to review the Court's Standing Order as they prepare the proposed Consolidated Pre-Trial order and in anticipation of their attendance at the Pre-Trial Conference. Parties must submit a Consolidated Pretrial Order by August 16, 2019, in

conformity with Uniform State Court Rule 7.2. Failure to respond to this calendar, or to file the proposed Consolidated Pretrial Order, may result in the parties and/or their counsel being held in CONTEMPT, and/or in the DISMISSAL of the complaint, answer, counterclaim, cross claim or third party, as appropriate.

All Motions in Limine shall be filed on or before August 16, 2019.

The removal of a case from the Pre-Trial/Jury calendar for any reason shall ONLY BE BY ORDER OF THE COURT AND MUST BE FILED WITH THE COURT BY AUGUST 16, 2019.

A Motion for Continuance and/or Extension of Discovery must be by consent of all parties and a Consent Order submitted; at the same time as the Motion is filed with the Clerk of the Court.

Lead Counsel is required to be present at the Mandatory Pretrial Conference on August 26, 2019 at 2:30 p.m. in preparation for the Pretrial conference. Parties are directed to:

- Bring a printed copy of the Consolidated Pretrial Order for the Court;
- Discuss settlement options prior to the Pretrial Conference and be ready to discuss settlement history with the Court;
- Discuss any motions in Limine that have been filed and make a good faith effort to resolve them; and
- Discuss any objections in depositions to be presented at trial and make a good faith effort to resolve them. All unresolved objections, together with argument and citations, shall be brought to the pre-trial conference, with a copy to the Court. Any objections not brought before the court prior to trial shall be deemed waived.
