Prior to your Zoom Hearing, before a videoconference:

- 1 You will need a computer with a webcam, a tablet, or a smartphone with speaker or headphones. You will have the opportunity to check your audio immediately upon joining a meeting.
- 2 We will email you the Notice of Hearing; the Notice will contain an approximate window of time for your video hearing.
- 3 When it is time for you to join the electronic hearing, the Court will email you a link that says "join via computer." It will also include the 9-digit (usually) Meeting ID. The link contains phone numbers for a conference call option; however, Uniform Superior Court Rule 9.1 requires both audio *and visual* communication for a video hearing.
- 4 ***IF YOU ARE UNABLE TO CONNECT TO THE LINK AT THE TIME OF YOUR CONFERENCE AND NEED TO COMMUNICATE WITH THE COURT, CALL 770.822.7511 AND LET THE JUDICIAL ASSISTANT, KNOW YOU ARE TRYING TO REACH THE JUDGE FOR YOUR HEARING.***
