

2. We will email you the Notice of Hearing, the Notice will contain an approximate window of time for your video hearing.
3. When it is time for you to join the electronic hearing, the Court will email you a link that says "join via computer." It will also include the 9-digit (usually) Meeting ID. The link contains phone numbers for a conference call option, however, Uniform Superior Court Rule 9.1 requires both audio *and visual* communication for a video hearing.
