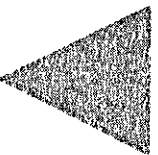

Parties are limited to 15 requests to charge excluding any Pattern requests, absent good cause shown.4. Responses to the motions in limine must be submitted to the Court no later than January 7, 2022. Failure to file responses to motions in limine will be deemed agreement therewith.
