PREJUDICE OF THE PLAINTIFF'S
ACTION. FAILURE OF THE
DEFENDANT TO APPEAR AT THE
CALENDAR WILL RESULT IN THE
STRIKING OF THE DEFENDANT'S
COUNTERCLAIM OR CROSS-
CLAIM, IF ANY. IF THE CASE HAS
BEEN SETTLED, DISMISSED, OR
OTHERWISE COMPLETED, UPON
PROVIDING NOTICE TO THE
COURT'S STAFF ATTORNEY, THE
PARTIES ARE EXCUSED FROM
APPEARING. IF PLAINTIFF
INTENDS TO DISMISS AN
ACTION IN LIEU OF APPEARING,
THE DISMISSAL AND FINAL
DISPOSITION FORM MUST BE
FILED NO LATER THAN FIVE (5)
BUSINESS DAYS BEFORE THE
HEARING, WITH A COURTESY
COPY EMAILED TO THE COURT'S
STAFF ATTORNEY AT [bill.ioeff-
fler@fultoncountyga.gov](mailto:bill.ioeffler@fultoncountyga.gov). IF
SERVICE OF PROCESS HAS NOT
BEEN EFFECTED, THE PLAINTIFF
MUST BE PREPARED TO
FACTUALLY DEMONSTRATE AT
THE STATUS HEARING DUE
DILIGENCE IN ATTEMPTING

SERVICE ON THE DEFENDANTS.
SHOULD THE COURT FIND THAT
THE PLAINTIFF HAS NOT
ADEQUATELY DEMONSTRATED
DUE DILIGENCE IN SERVING THE
DEFENDANTS, THE CASE SHALL
STAND DISMISSED FOR WANT
OF PROSECUTION. IF THE CASE
HAS BEEN RESET TO THIS
CALENDAR FROM A PREVIOUS
STATUS HEARING CALENDAR OR
PEREMPTORY CALENDAR, NO
FURTHER RESET FROM THIS
CALENDAR WILL BE GRANTED
ABSENT EXTRAORDINARY
