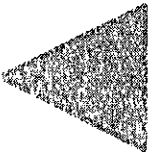

Cases listed below appear on Judge Shukura Ingram's Civil Jury/Non-Jury Trial Calendar commencing on the above date at 9:30 A.M. in Courtroom 7E of the Justice Center Tower, 185 Central Ave. S.W., Atlanta, GA 30303. The order in which the cases will be called to trial will be at the discretion of the Court. **THERE WILL BE NO CALENDAR CALL.** All positions on the calendar will be placed on a two hour call. For all cases, exhibits should be numbered and exchanged with opposing counsel prior to trial. For jury trial cases, a consolidated pre-trial order is due by close of business on March 23,

2022 unless otherwise indicated in a separate notice of trial. Failure to submit a consolidated pre-trial order will be deemed an election to proceed with a bench trial. Jury charges should be submitted in written and electronic MS WORD format to the staff attorney's email address. Jury charges are due at the call of the case for trial unless otherwise directed. Pre-trial conferences will be held via Zoom on April 11, 2022. Parties shall follow the Civil Standing Order and **MUST** use the Civil Consolidated PTO template prescribed in Uniform Superior Court Rule 7.2.

Parties are directed to email the staff attorney and provide the estimated length of trial, the chances of settlement, and the results of their mediation of the case by March 23, 2022. The Court will **NOT** provide a court reporter automatically. If you want the trial or any pre-trial hearings taken down, you will need to make arrangements to **PROVIDE YOUR OWN** court reporter. **IMPORTANT:** Any cases listed herein not reached on this **APRIL** trial calendar will automatically appear on the next trial calendar which, in this instance, begins on **MAY 11, 2022** at 9:30 A.M. and this is considered the parties' **NOTICE** of such hearing date for their case if not reached in **APRIL 2022**.
