THE FOLLOWING CASES APPEAR FOR A STATUS CONFERENCE OR FOR ORAL ARGUMENT AND WILL BE HEARD VIRTUALLY. EACH SIDE WILL BE PERMITTED 15 MINUTES FOR ORAL ARGUMENT. PARTIES REQUIRING MORE THAN 15 MINUTES OR WITNESS TESTIMONY SHALL NOTIFY THE COURT WITHIN SEVEN (7) DAYS OF THE CALENDAR'S PUBLICATION. FAILURE TO APPEAR FOR THE CALENDAR SHALL BE CONSTRUED AS A WAIVER OF ORAL ARGUMENT, AND THE MOTION MAY BE DISMISSED FOR WANT OF PROSECUTION. ALL RELEVANT DISCOVERY MATERIALS AND RESPONSIVE MOTIONS SHALL BE FILED WITH THE COURT FIVE (5) DAYS IN ADVANCE WITH A COURTESY COPY PROVIDED TO CHAMBERS. ATTORNEYS OF RECORD SHALL NOTIFY PRO SE PARTIES AND ATTORNEYS WHO ARE OUT OF TOWN/STATE BY U.S. MAIL AND FILE A COPY OF THE NOTICE IN CHAMBERS PRIOR TO CALENDAR CALL.
