The following cases will be tried during a period BEGINNING OCTOBER 10, 2022, and ENDING on DECEMBER 2, 2022.

There will be a Virtual Zoom Calendar-Call/Pre-Trial Conference on TUESDAY October 4, 2022, at 10:30 a.m. attorneys appearing must be the attorneys trying the case or another attorney of record authorized to define the issues and enter into stipulations. Cases are listed in NUMERIC order, NOT in their position for trial.

All cases will remain on a two-hour notice/call throughout the remainder of the calendar. During this trial calendar, your case may either be tried by Judge Dixon or a Senior Judge. As a result, your case will appear on Judge Dixon's calendar and may also be noticed for and appear on a Senior Judge's calendar. The parties should be prepared to try their case before Judge Dixon or a Senior Judge. This is a continuing calendar: all cases that are not reached will be carried over to the December 5, 2022, Jury Trial Calendar and every calendar thereafter until they are reached.

The October 10, 2022, Jury Trial Calendar-Call will be October 4,

2022, using the same Zoom link listed below that was used for the Court's July 29, 2022, Calendar Call.

Voir Dire/Jury Selection will begin with jurors who are in person and with counsel in-person in courtroom 3A at the Fulton County Courthouse on October 10, 2022, at 12 p.m. The trial will begin at the conclusion of voir dire.

All parties are required to submit Requests to Charge limit 15 for non-pattern charges via Microsoft Word and a

Consolidated Pre-Trial Order the Court will not accept Pre-Trial Orders from each party separately via email no later than 12:00 p.m. on October 3, 2022, to Mrs. Ottrell Edwards ottrell.edwards@fultoncountyga.gov, the Court's Staff Attorney. Please send the full text of each of the charges you are requesting and not merely the charge number. Please ensure you are using current pattern charges. If Pre-Trial Orders and Request To Charge Have Been Previously Submitted, It Will Not Be Necessary To Submit Additional Ones.

Please review the calendar and inform Staff Attorney Edwards of any corrections needed to be made to the names of parties and associated counsel who will appear for the call of the calendar. Also, note that any corrections to the listed names should also be updated with the Clerk's office.

If you are a Plaintiff, a failure to report and appear at the calendar call may result in your case being DISMISSED FOR WANT OF PROSECUTION. If your case is called to trial, and you are not ready to proceed to trial your case will be DISMISSED FOR WANT OF PROSECUTION.

If you are a Defendant, a failure to report and appear at the calendar call may result in the entry of a DEFAULT JUDGMENT. In addition, if Defendant fails to appear, Plaintiff may be allowed to present evidence of damages and a final judgment may be entered as to damages. If the Defendant has a counterclaim, a failure to report and appear at the calendar call may result in your COUNTERCLAIM being

DIMISSIED FOR WANT OF PROSECUTION.

There will be no continuances granted except for statutory grounds. All conflicts and requests for continuances must be in writing and in this office by September 29, 2022, at 3:00 p.m.

DURING THE COURT'S EIGHT-WEEK CALENDAR, PLEASE DO NOT CALL OR EMAIL CHAMBERS TO FIND OUT WHEN YOUR CASE IS GOING OUT. YOU WILL BE GIVEN SUFFICIENT NOTICE BEFORE YOUR CASE IS SET FOR TRIAL. THE COURT WILL NOTIFY PARTIES WHEN A CASE IS CALLED FOR TRIAL.
