**SERVICE:** Service upon all defendants must be perfected no later than Monday, November 14, 2022 with WRITTEN PROOF OF SERVICE filed and emailed to the Court at [ritu.bahri@fulton-countyga.gov](mailto:ritu.bahri@fulton-countyga.gov) no later than Tuesday, November 15, 2022. The Court will not grant any resets other than for legal cause. Failure to do so will subject the case to immediate dismissal without prejudice.

#### BENCH TRIAL CASES:

Attorneys and pro se parties shall submit a JOINT WRITTEN REPORT no later than November 14, 2022 via email to [ritu.bahri@fultoncountypa.gov](mailto:ritu.bahri@fultoncountypa.gov) with the case status and shall include the following information:

1. Attorney names and parties represented;
2. Contact information for any pro se parties;
3. Expected length of trial;
4. MOTIONS: Whether there are any motions pending that require a ruling, and if so, indicate the title of the motion and the date it

was filed.

**5. DEFAULT LIQUIDATED:** For cases in DEFAULT with liquidated damages, Plaintiff must file a Motion for Default Judgment no later than Monday, November 14, 2022. In that event, a copy Motion for Default Judgment shall be sent to the Court via email listed above.

**6. DEFAULT UNLIQUIDATED:** For cases in DEFAULT with unliquidated damages, Plaintiff must file a Motion for Default Judgment as to liability and request a hearing for damages therein no later than Monday, November 14, 2022. In that event, a copy Motion for Default Judgment shall be sent to the Court via email listed above. In addition, an affidavit supporting the claim for unliquidated damages shall be filed not later than Monday, November 14, 2022.

**SUBROGATION CASES:** Plaintiff shall file an affidavit supporting the claim for unliquidated damages no later than Monday, November 14, 2022.

**FAILURE TO TIMELY SUBMIT A WRITTEN REPORT SHALL RESULT IN THE DISMISSAL OF THE COMPLAINT OR THE STRIKING OF THE ANSWER AND THE ENTRY OF JUDGMENT BY DEFAULT.**

The parties are reminded of Rule 22: ; Use of Recording Devices & Cell Phones; which provides as follows:
