2. Contact information for any pro se parties;
3. Expected length of trial;
4. **MOTIONS:** Whether there any motions pending that require a ruling, and if so, indicate the title of the motion and the date it was filed.
5. **DEFAULT LIQUIDATED:** For cases in **DEFAULT** with liquidated damages, Plaintiff must file a Motion for Default Judgment no later than May 1, 2023. In that

event, a copy Motion for Default Judgment shall be sent to the Court via email listed above. **FAILURE TO TIMELY SUBMIT A WRITTEN REPORT SHALL RESULT IN THE DISMISSAL OF THE COMPLAINT OR THE STRIKING OF THE ANSWER AND THE ENTRY OF JUDGMENT BY DEFAULT.** It is the parties' responsibility to request a Court Reporter. In-house Reporters are available by contacting Monica Bailey at Monica.Bailey@fulton-countyyga.gov. Alternatively, parties may hire an outside Reporter. The parties' failure to arrange for a Court Reporter will result in the matter not being taken down. The parties are reminded of Rule 22: Use of Recording Devices & Cell Phones; which provides as follows: Parties participating in

remote proceedings and persons viewing live streams of such proceedings are reminded of the prohibition against photographing, recording, and rebroadcasting court proceedings. Uniform Superior Court Rule 22C-D.
