**CONTINUANCES:** Pursuant to Rule 8.5 (U.S.C.R.), continuances **WILL NOT BE GRANTED MERELY BY AGREEMENT**. All requests for continuance shall be submitted in pleading form, **at least five (5) days prior to the beginning of the first trial week**. Requests shall contain the following information: Reason for the continuance, length of time to be continued (i.e. 30, 60, 90 days), opposing counsel or party agrees to continuance; if continuances have been previously granted, to which party and for what reason; an Order for Judge's signature in the event the request is granted. It is the responsibility of the requesting party to ascertain if a continuance has been granted and to notify all parties.

**TRIALS:** All cases on the calendar are subject to being called for trial. Beginning Friday, July 7, 2023, there will be a daily recording after 3:00 p.m. of the cases required to appear the next day. **Counsel and Pro Se litigants should call that recording line daily after 3:00 p.m. at (770) 822-8654.**

**DISMISSALS AND SETTLEMENTS.** Any dismissal shall be submitted to the Clerk and a copy forwarded to Cassie Gaubert. Settlement paperwork **must be approved** by the Court **BEFORE** your case may be removed from the calendar. Similarly, in the event your case is settled at court, all settlement paperwork **must be approved** by the Court **BEFORE** you are excused.

**COURT REPORTER:** Your case may be taken down by the Court Reporter. The fee is approximately \$43.00 per hour (or \$21.50 per hour if cost is shared between the parties). **Be prepared to make immediate payment at the time 'take down' is completed.**
